REFUND POLICY A \$100.00 non-refundable deposit, is payable within 7 days of the first meeting to secure your booking. Final payment to be made 2 weeks prior to the ceremony; and refundable up to 1 week prior to the ceremony. In the event that my services are cancelled within 1 week of the ceremony, there will be no refund. In the event that I have to cancel my services, money will be refunded in full. In the event that some of my services are not required, there will be no reduction in the total cost.

By signing this document we acknowledge and agree that:

- The fee, to be discussed at the initial meeting, for Rebecca Morrison (the Celebrant) to design and deliver our wedding.
- We will complete this Ceremony Booking Form at the first meeting, or within 7 days of our first meeting, in order to secure our booking on the time and date of our choice.
- Our tentative booking will lapse after 7 days if the Ceremony Booking form and non-refundable deposit is not received.
- > Travel by the Celebrant over 100kms from residence in Ferntree Gully, Victoria, is an additional fee to be charged at 50 cents per kilometer. This applies to both rehearsal and ceremony.
- > If required, suitable accommodation for the Celebrant will incur an additional charge.
- The ceremony will not take place if all of the required documents have not been sighted and all the relevant documents signed within the legally required time.
- > The total fee MUST be paid with 14 days prior to the ceremony.
